As this event will be on campus and free for Illinois students, I recommend we fund it at 100%
- *Funding type:* Programs

- **App No. 159- Women in Mechanical Science and Engineering**
  - *Description:* Application is requesting funding for supplies to be used during community promotion events targeted towards minority populations on campus.

As the events will be on campus and free to Illinois students, I recommend we fund the application 100%. (Note: RSO claims \$1.6 quintillion in additional funding. This is presumed to be a typo. UPDATE: RSO has additional funding of "\$4,558.89 but it is not currently accessible to them". The number inputted was their CFOP account.

  - *Funding type:* Services
  - *Amount Requested:* \$938.16

  - *Description:* This application is requesting funding for an event where the organization will be hosted by MED members and UIUC faculty to help students who are interested in furthering experimental methods/ research of their choosing. This application does well in providing details and support's their organization's mission statement
  - *Connection:* Mu Epsilon Delta is a co-educational pre-health professional fraternity whose mission is to prepare our members on their journey to the healthcare field through the development of scholarship, brotherhood, and service. With this in mind, both Basic Life Support training and MCAT testing supplies fall under the criteria of our mission. BLS is a certification that opens up many doorways for entrance level clinical positions; something that is absolutely crucial in order to become a medical professional. Taking on a position like this allows for a pre-health individual to express their interest in dedicated, and selfless service for the community around them. MCAT testing supplies will not only further the development of scholarship, but brotherhood as well. The definition of scholarship is as follows: "academic study or achievement; learning of a high level." Providing our members with these supplies will greatly increase their level of higher learning, therefore paving their way toward the tremendous academic achievement of being accepted into medical school. In terms of brotherhood, these books will allow MED to host group MCAT study events for our members; providing everyone with the same all-encompassing MCAT study source would allow for collaborative studying. We believe that providing our members with the opportunity to use the same study source would create an environment in which they may learn at their own pace while also being able to discuss content with their MED brothers to gain a deeper understanding of the material, giving them all of the resources and help they need to prepare for the MCAT. With that, these scheduled study sessions will also allow our new members who are freshmen to acclimate themselves to the college workload and learn how to properly time manage their coursework with their other extracurricular commitments

  - *Description:* ARC multipurpose room rental for research networking event
  - *Event Description:* A research expo event hosted by MED involving MED members and UIUC faculty engaged in research. The event will be free to attend for all UIUC students interested in the research occurring on our campus, allowing them to learn about fields of research that they may want to further explore. At the event, MED members and their respective PI will present and explain their research findings from the 2023-2024 academic year and discuss their future plans for further research or new experimental methods. This event will allow MED members and other UIUC students interested in medical research to meet and network with UIUC faculty that lead cutting edge research. These connections will allow students to pursue and obtain undergraduate assistant positions in research labs at UIUC, giving them a great deal of experience in research practices and an opportunity to show medical schools that they are a well-rounded, holistically sound applicant

- **App No. 59- Learners of Indigenous Languages of Illinois**
  - *Description:* Application is requesting funds for indigenous books and works that deal with the curation and maintenance of languages
  - *Connection:* Learners of Indigenous Languages of Illinois (LILI) aims to “learn and practice languages of Indigenous peoples whose ancestral homelands fall within modern-day Illinois, including ... Potawatomi, Miami, [and] Peoria” and “build relationships with Indigenous peoples” (Articles of Incorporation, 2023 Sep 08). We propose to purchase language learning materials for the Miami and Peoria languages and the Potawatomi language. In our budget proposal, line items #4, 7, 9, and 13 describe the vocabulary, grammar, and/or structure of these languages. Line items #3, 6, 15, 16, and 17 are writings by first speakers which give us insight into how stories and lessons are passed down from Indigenous Elders to children from cultural and linguistic standpoints. These texts are essential for us to understand Indigenous cultural worldviews and priorities, which will allow us to build more equal and beneficial relationships with these peoples
  - *Reviewer's Notes:* This application is requesting funds for books/ works that deal with learning and practicing of languages that have started to become less common. Mainly focusing on tribes and people that reside in native locations and areas that used to be home to many other natives. Based on the application, all items prove essential to the organization's mission statement and overall success
  - *Funding type:* Services
  - *Amount Requested:* \$4,981.10

- *Amount Allocated:* \$4,981.10
- **App No. 86- Association of Food Technologists**
  - *Description:* Application is requesting chocolate to offer guests attending. The chocolate is in relation to the Chocolate Event and proves essential to its success

- **App No. 87- Political Science Graduate Student Association**
  - *Description:* Application is requesting funding for event fees and lodging
  - *Connection:* PSGSA pursues to enhance the academic and professional experience of the Illinois Political Science graduate students by (1) providing training events, academic resources, and mentorship to graduate students and (2) facilitating channels for feedback and representing graduate students in discussion. PSGSA hopes to assist Illinois Political Science graduate students to present their work in academic society, get feedback, develop their research, and settle in academia. I recommend SORF funds based on proper documentation that proves beneficial and successful to their purpose
  - *Funding type:* Services

  - *Description:* Application requests funds for the purchase of teas, sodas, and supplies that prove beneficial to the event's goal

Along with tea, attendees will learn a little about flavor chemistry and the sensory impression behind it. At this event, students will be able to try a variety of teas and sodas with different flavors
  - *Reviewer's Notes:* This application is requesting funds for items related to the event's purpose and overall success of it. The items listed are deemed relevant and therefore on the task for funding from SORF. It will take place on campus and be free for Illinois students with 0% non-Illinois attendees, therefore I recommend full Fund from SORF
  - *Funding type:* Programs
  - *Amount Requested:* \$78.86
  - *Amount Allocated:* \$78.86
- **App No. 112- IlliniFurs**
  - *Description:* This application is requesting funding for a service where the organization will be evenly distributing the funds to help hotel expenses to attend a convention in Rosemont, Illinois.   - *Reviewer's Notes:* Application can be funded for totality of 1,281\$ per SORF's standards, but it is to note that within their supporting documents they state they are requesting for more

  - *Connection:* They are essential items for high-performance cycling, specifically racing. Since a central purpose of our club is to enable access to bike racing, these are items without which our club cannot operate in a meaningful capacity
  - *Reviewer's Notes:* Illini Cycling is requesting funding for required uniforms — shirts and bib shorts — that are needed in competitions. A mock-up of these uniforms was sent and had the appropriate UIUC logo. Thus, I recommend funding all of their requested amount of \$4,158
  - *Funding type:* Services
  - *Amount Requested:* \$4,158.00

- **App No. 110- Illini Student Musicals**
  - *Description:* Illini Student Musicals is requesting funding to rent out Lincoln Hall so they can practice for their upcoming musical
  - *Connection:* Every semester, ISM's core mission is to produce a musical production put together by over 100 student cast, staff, and pit orchestra members. We will be rehearsing for 8 weeks in preparation for our Spring 2024 performance, and this funding is crucial for allowing us to have rehearsals in our venue at Lincoln Hall Theatre
  - *Reviewer's Notes:* Illini Student Musicals is asking for funding for space to practice in Lincoln Hall Theater for their upcoming musical — a main part of their RSO's mission statement.

Thus, due to its essential need to the RSO's operation and success, I recommend allocating the full amount of \$4,412.5

- *Funding type:* Services

Udaan's unique audience includes students in and outside of the UIUC campus, nationwide members from the Desi Dance Network, and performers and audience members of Udaan itself, summing to outreach to approximately 12,000 people. Our event is open and free to the general public, specifically catered towards UIUC students, and is marketed on multiple social media platforms, months prior to the event.
  - *Team/Judges Application process:*
    - Prior to hosting our 8 competing teams, we have an extensive application process. This past year we had 70+ teams apply with their audition video, and we had a 2 day long viewing of these videos, in which a board of 15 of our members watched and judged, until we had our final 8 teams selected. The process is quite competitive, due to the limited number of spots available and the increasing amounts of talent and creativity we see every year.
    - These 8 competitive teams are then judged at our competition by 5-6 extremely qualified judges from various dance backgrounds. We reach out to well-known dancers, and dance teams to gauge interest in judging, and we then select from a pool of applicants. We try to balance the panel by having judges with different dance backgrounds, experiences, and expertise to be able to provide the competing teams with a broad range of judges in the panel so that all their ideas, choreography, and creativity is equally and correctly judged to ensure a fair competition
  - *Competition Weekend:*
    - Every team is given 3 liaisons - which are all University of Illinois Urbana Champaign students. These individuals relay information about our competitions times and events and guide the performers around our campus. Udaan hosts two major events. The first event, "The Mixer" is held the night before the competition. At the mixer, there is dinner served to the dancers, games set up, and a grand welcome to our campus. The purpose of this mixer is to have all the dancers be able to meet the rest of the teams invited to the competition and play games in which we determine the show order for the competition the next day. The following day, teams woke up bright and early to come to our show's tech rehearsal time. From there, we provide breakfast, lunch, and tons of water for these individuals to make sure they are well-

nourished throughout the exhilarating weekend. After tech time, teams get ready at their hotels until it's show time. During show time, we have each team perform their 10-minute-long dance sets. We have a photographer set up a live stream for the thousands of people involved in the dance circuit to log in and watch, a DJ to run the music, and exhibition acts to showcase the University of Illinois' talent. The judges carefully deliberate and speak to our national managers to finalize their scoring rubric and prepare to announce the placements of the competition. Once the show is over, we allow our teams to celebrate themselves and their performance by exploring our campus! The following day, the team members fly back/depart Champaign and go back to their universities with the best image of UIUC

Further, their costs for Virginia Theater exceed \$999, so we could only fund up to that. Because of the 25% of \$999, I recommend allocating \$249.75 as it is needed for the event to occur

  - *Event Description:* In pursuit of the long-term project goal of reaching the Karman Line, the official edge of space, the Illinois Space Society's Spaceshot team is competing in the unlimited altitude division of FAR-51025 (Friends of Amateur Rocketry-51025). This is a competition in Mojave Desert, California that awards points based primarily on altitude. ISS previously annually competed in the Spaceport America Cup, formerly known as IREC. ISS has competed in the Spaceport America Cup since 2019, placing 6th in 2019, 4th in 2021, and 2nd in 2023.     - **Eyepieces (\$1,086.98):** The Astronomical Society uses the dome observatory and its small reserve of club telescopes for almost all of its functions, including observing at regular meetings, open houses, and dark side trips. Through our telescopes, we serve the CU community by allowing them to see the Moon, planets, and even galaxies, nebulas, and other astronomical objects. Our free and public monthly open houses have had over 750 visitors since we resumed them from COVID. The attendees range from UIUC students and alums to families from the CU area bringing their children. However, the quality of these observing nights depends on the eyepieces we use. To enhance these experiences without acquiring expensive telescopes, we request funding for two eyepieces; the 16mm Type 5 TeleVue Nagler eyepiece and the 31mm Type 5 TeleVue Nagler eyepiece offer a wide field of view and excellent optics and are compatible with almost all of our telescopes and will benefit our 200+ current members and the general public for years to come.
    - **Camera Mounts (\$1369.95):** To capture the night sky's beauty and inspire fascination with the universe, the Astronomical Society participates in astrophotography, which requires advanced mounts to track celestial objects as the Earth rotates. Additionally, telescopes can be attached to these mounts, allowing us to engage the public in more quality observing as we don't have to manually adjust the telescopes every few minutes. Thus, to improve the quality of our astrophotography and the public's visual observing, we seek funding for two camera mounts:
      - **Skywatcher Star Adventurer 2i Pro Pack:** A general-use mount that supports DSLR cameras and small telescopes with an 11 lbs payload, enhancing astrophotography with features like a camera control port, guiding port, and Wi-Fi control.
      - **Skywatcher EQ-35 mount:** An intermediate level computerized mount with a 35 lbs payload, go-to functionality, tracking, autoguiding, and compatibility with larger telescopes.
    - **Dark Site Trips (\$636):**In alignment with our mission to promote cosmic appreciation and learning, we organize trips to dark sites free from light pollution. These trips introduce many to the Milky Way, meteor showers, and other wonders not visible in light-polluted areas like our campus. To maximize the audiences, we showcase the cosmos to, we often collaborate with other RSOs, such as the Society for Physics Students, the Outdoor Adventure Club, and more. Our primary dark site is the Middlefork Forest Preserve, approximately 30.2 miles away (\$35.334 per car / per 5 people, based on 58.5 cents, IRS Gas Calculation). We anticipate 3 Dark Site trips

with an average of 30 passengers / 6 cars to Middlefork-distance Dark Sites for the period from December 6, 2023, to May 31, 2024, though size, distance, and location of Dark Site trip varies.  $(6*35.334*3) = \$636$ .

- Total Solar Eclipse Trip (\$1881.44): For the total solar eclipse on April 8th, 2024, Illinois and Indiana are in the path of totality. As such, UIAS intends to organize a special trip and bring as many U of I students as possible, as the next time this happens will be in 2044. Our mission of achieving sustainability, as we aim to repurpose wood waste and reduce its environmental impact significantly needs sandpaper for the wood used to be repurposed. By creating smoothed frames from discarded wood, we not only enhance their aesthetic appeal but also contribute to a more eco-friendly and responsible approach to woodworking, aligning with Illinois Enactus' mission
    - 18oz Wood Glue ultimate: Wood glue is essential when building frames, serving as the binding agent to assemble the individual wood pieces of our frames. Without wood glue, we cannot create the final product of a rectangle frame. It plays a critical role in joining these pieces together to form a sturdy and cohesive structure. Through this process, we transform separate wooden elements into a finished rectangular product that fulfills our mission of repurposing wood waste and reducing environmental impact of wood waste as well.

- 12 Pieces of Back Boards: Back boards are used to providing support in the frames we create for our project. Without backboards, these frames cannot be used for pictures, and such is our desired end product. These backboards play a crucial role in framing, providing essential structural support and safeguarding the artwork they encase
