Student Engagement has several changes with student organization management to share, given some recent additions, transitions, and future software implementation.

# **President, Treasurer, Event Registration & SORF Orientations**

This summer, we launched online orientations via Canvas to provide the flexibility and ease of access to complete this requirement. In-person orientations will continue to be offered starting in September. Both online and in-person orientations now require a quiz, which each officer must achieve 100% on to receive credit for completion. To access the new orientations, click here.

#### **President & Treasurer Orientations**

Starting this year, orientations must be completed within the Cycle Dates to which your student org is assigned. Therefore, if you are a continuing President or Treasurer from the previous cycle, you must complete the orientation again. While we understand this is a departure from our previous practice, this new expectation ensures you receive the most up-to-date information regarding your position.

- Orange Cycle: June 1 May 31
- Blue Cycle: December 16 December 15

### **Event Registration Orientation – NEW**

We've implemented a new orientation for Event Registrations to educate on the process and reduce the likelihood of a denied submission. **This is a new requirement for any of the five required officers** (*President, Vice President, Secretary, Treasurer, Membership Director*) **to submit an Event Registration.** The updated President Orientation will no longer include this information; therefore, if the President wishes to submit an Event Registration, they must complete this orientation.

SODA will begin requiring the Event Registration Orientation completion for any Event Registration submitted on or after Friday, September 1.

### **Student Org Management System Change**

Our contract with the vendor of the Involved@Illinois platform ends this month. Given this system's many challenges and limitations, including shared feedback from student leaders, we will be implementing a new, more robust, and user-friendly system in September/October.

## Involved@Illinois Platform Access Ends – Tuesday, August 29 at Noon

The Involved@Illinois platform will no longer be accessible starting at Noon on Tuesday, August 29. In preparation for this transition, the SODA and SOFC staff is downloading the following information, which will be uploaded to the new system later this semester:

- 3. Event Attendance
- 4. Purchase Requests
- 5. Annual Student Org Registrations

In preparation for access removal, we recommend your student org access your student org profile and download any documents and media members may have uploaded over the years.
